- 1. I would rename it something other than "clarification." I get you are re-emphasizing the need for a strategic plan, especially in light of the fact that the previous one was never formally adopted. However, that word clarify has a connotation of being apologetic, as if you stated something wrong that you need to reword or rethink. It will be an uphill battle for the council to accept that this something we should do the way it is, and I don't want several of the opposing voices to get the impression that they have strong armed you and talked you away a bit from your proposal. Hope that makes sense.
- 2. I don't mind that you distribute something in advance of the COW on the 25th, but I would recommend waiting until after the voting meeting next week. Then afterwards ask Peggy to distribute it or have it part of the COW agenda packet for the 25th. That way a fuller discussion can be had with our guest.
- 3. If you haven't done so already, be sure you let the gentleman know before he comes that he might expect some backlash. That way he can be more adequately prepared to answer any such questions posed this past week. The better he is able to address the qualms, the more accepting the council might be in moving forward.

I appreciate you taking this initiative on. I hope it goes well. If not, it will be 10 years or after this current council has departed the scene before another strategic plan attempt can be made. Fingers crossed.
